### Signature form

A parent or legal guardian must sign this form if the applicant is under 18 years old. For digital applications, the completed form must be uploaded under the alternative "signature by parent".

- 4) If you do not have space to fit your identification in this section you must copy the identification on a different page and send this together with your application.

# Guide for filling in the signature form

## The parent or legal guardian confirm that

### Item 1: Applicant's full name

State the first and last names of those under the age of 18 who are applying for a police certificate.

### Item 2: Norwegian ID number

State the Norwegian ID number of the person under the age of 18 and who is applying for a police certificate.

### Item 3: Applying for a police certificate for the following purposes:

State the purpose of the application for a police certificate. Normally, this will be an offer of a position or position with a requirement for a police certificate, or an application to public authorities with a requirement for a police certificate. ### Item 4: Recipient of police certificate

State who will receive the police certificate. Normally this is an employer or client.

## Information about the parent or legal guardian

### Item 5: Full name

State the first name and last name of the person who is the parent (or legal guardian) of the person applying for a police certificate.

### Item 6: Norwegian ID number

State the birth and social security number of the parent (or legal guardian).

### Item 7: Postal address

State the postal address of the parent (or legal guardian) here.

### Item 8: Postal code and city

State the postcode and place for the postal address.

### Item 9: E-mail

State the e-mail address of the parent (or legal guardian).

### Item 10: Telephone number

State the telephone number of the parent (or legal guardian).

## Copy of the parent's or legal guardian's identification

### Item 11: Copy of valid identification

Valid identification: passport, national ID card, Norwegian bank card with photo, Norwegian driver's license, Ministry of Defence ID card (from 2004), valid postal ID card issued after 01.10.94, national ID card issued within the EEA area, Norwegian travel document for refugees (green passport), Norwegian immigration passport (blue passport) and residence permit card (both sides).

Regarding Norwegian passports issued after 19.10.2020 we need a copy of the front and back of the personnel page to get the complete information about you.

The application form must be dated and signed by the applicant's parent or legal guardian (the person who fills in the signature form).
