

Request for Access to Personal Data in the Border and Territorial Control Register and/or Entry/Exit System (EES)

You can request confirmation of whether the police collect and use information about you, and what information this concerns. You can also request a copy of the information. As a general rule, you do not have access to information about other people.

The right of access is provided by Article 15 of the General Data Protection Regulation (GDPR). For the Entry/Exit System, this right is also outlined in Article 52 of the EES Regulation.

You can use this form if you wish to request access to your personal data in the Border and Territorial Control Register and/or Entry/Exit System (EES) according to GDPR Article 15. Once you have completed the form, you can send it to Øst Police District(PO Box 3390, 1402 Ski).

The police advise that you should not send the form by email, as email is often sent unencrypted. Confidential, sensitive, or other classified information should not be sent via email, including messages containing a national identification number (fødselsnummer).

The response to the request for access will be sent to the address registered in the National Registry. If you do not have a registered address in Norway, the response will be sent to the address provided in this form.

Parents/guardians can request access to information about their child up until the child turns 15 years old. The request must be signed by a parent/guardian. From the age of 15, the person the information concerns can request access themselves under GDPR. Parents may exercise the right of access on behalf of children over 15 when the child consents and, in some cases, when necessary to fulfill parental responsibilities.

Border and territorial controll register

The Border and Territorial Control Register is a national registry of travelers intended to assist the police with administrative tasks related to entry and exit control and immigration control within the territory. The processing of information in the register also has a crime prevention purpose. Specific regulations for the register are provided in Chapter 5 of the Border Regulations.

The police record information about the person, travel ID/document and the time and place of border crossings/immigration controls.

Entry/Exit System (EES)

The Entry/Exit System (EES) is a European-wide information system that records entry, exit, and refused entry data for third-country nationals on short-term stays who cross the external borders of the Schengen area. It records information about the person, travel document, and visa, as well as fingerprints and facial photos. Specific regulations for the system are provided in the EES Regulation (EU 2017/2226).

Have you remembered to attach identification?

The request for access must be signed, and a copy of valid identification must be included. See under Identification for what constitutes valid identification.

Copy of Valid Identification Must Be Attached for Us to Process the Request. The identification must not be expired. Note that the name, national identification number, and photo must all be clearly visible on the copy you provide.

What do we accept as valid identification?

- Valid passport (not emergency passport)
- Norwegian bank card with photo
- Norwegian driver's license original and duplicate (not older driver's license "green driver's license")
- Nordic driver's licenses of EU/EEA standard
- Ministry of Defence ID card (from 2004)
- Valid postal ID card issued after October 1, 1994
- National ID card issued within the EEA
- Asylum seeker ID card, along with a signature and place of birth
- Norwegian refugee travel document (green passport)
- Norwegian passport for foreigners (blue passport)

The purposes of the processing of the personal data.

To whom the police have disclosed or will disclose the information, especially if the information is disclosed to recipients in countries outside the EU/EEA or international organizations.

How long the data will be stored, and possibly the criteria used by the police to determine the storage period.

My rights related to rectification, erasure, restriction and to object to the processing.

If the data was not collected from me, where it was collected from.

Whether the police make automated decisions on the basis of the data, and if so, what logic underlies these decisions, as well as the consequences this may have for me as a data subject.
