## Attachment to application for a police certificate of conduct for applicants under the age of 18

### Signature form for parent or legal guardian

A parent or legal guardian must approve the application for a police certificate of conduct if the applicant is under 18 years old.

It is sufficient for the parent or legal guardian to sign the application form if you apply by post.

You can use this form if you apply digitally. The form can be uploaded in the application portal under the alternative "Signature by parent".

The form must be filled in by the parent or legal guardian.

## Guide for filling in the signature form

The form must be filled in by a parent or a legal guardian to the underaged person applying for a police certificate of conduct.

### **Box 1 and 2: Full name and Norwegian ID number**

State your full name and Norwegian ID number (birth date and social security number) or D-number here. If you don't have this, state your date of birth.

### **Box 3 and 4: Postal address, postal code and city**

State your postal address, postal code and city here.

### **Box 5 and 6: E-mail and telephone number**

State your e-mail address and telephone number here.

### **Box 7 and 8: The applicant's full name and Norwegian ID number**

State the full name and Norwegian ID number (birth date and social security number) of the person under the age of 18 who is applying for a police certificate of conduct. If they don't have a Norwegian ID number, state their date of birth.

### **Box 9: The applicant is applying for a police certificate of conduct for the following purpose:**

State the purpose of the application for a police certificate of conduct, for example that the underaged person have been offered a position with a requirement for a police certificate of conduct, or that they will send an application to public authorities which requires that they present a police certificate of conduct. ### **Box 10 and 11: Place, date and signature**

The signature form must be dated and signed by one of the applicant's parents or legal guardians. The signature must be original and handwritten on the form. We do not accept a signature written on a computer or otherwise, nor a picture of a signature, for instance on a passport or debit/credit card.
